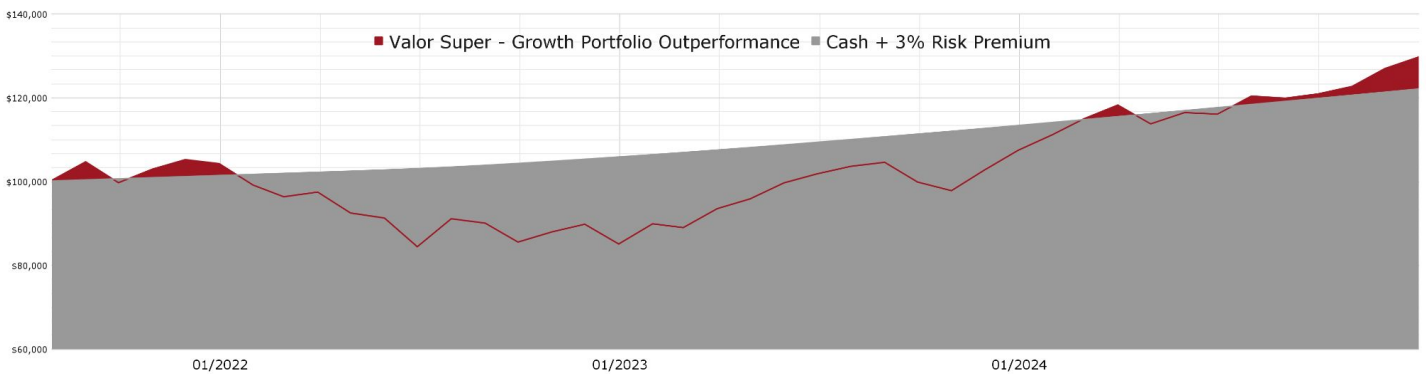

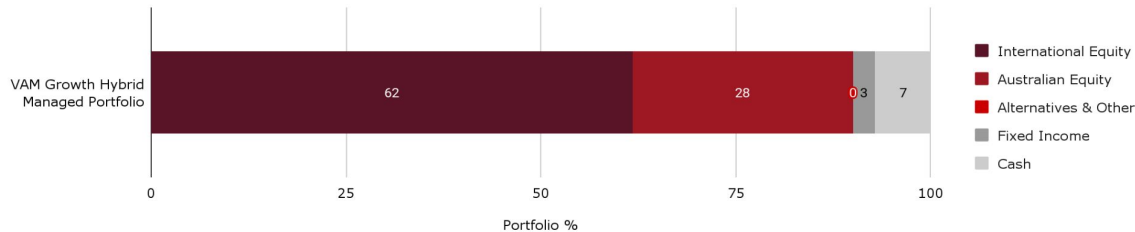

Performance since inception to 31/12/2024



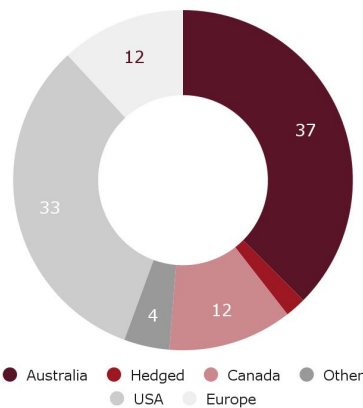

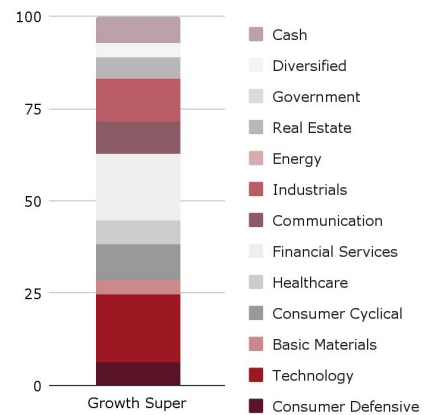

Performance since inception to 31/12/2024



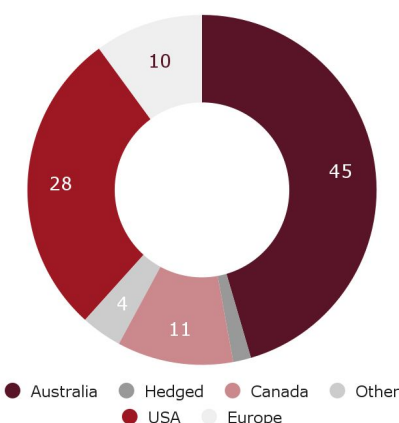

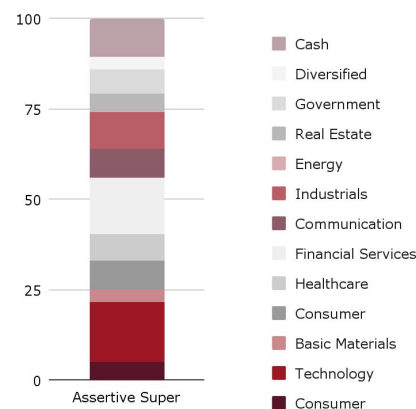
